Annual Meeting Agenda Details

Healthcare - Changes & Updates provided by John Tucciarone & Ted Mazella

AT&T Healthcare Benefit Summary & Status

In 2024 AT&T changed their non-grandfathered health benefits for all retirees & eligible dependents to a company-subsidized plan provided by UnitedHealthcare (UHC). For 2025 enrollment to the AT&T UHC PPO (ATTMAP) Group Medicare Advantage (PPO) Plan required no further action, unless joining for the first time. Major changes were that dependents are now free v. a \$50 monthly premium, for at least this year. Service Co-Pays were increased along with a partial payment of the Medicare deductibles.

The AT&T Group Medicare Advantage (PPO) Plus Plan monthly premium of \$50 remains the same (dental, vision, and expanded hearing coverage).

Revised Out-of-Pocket Costs for Non-grandfathered Retirees.

- Monthly Premium: \$0 for retiree or spouse
- Annual Medicare Deductible: \$125
- Out-of-Pocket Maximum: \$900 + Medicare deductible
- Primary Care Physician/Specialist Visit: \$20/\$40
- Emergency Room: \$135 (Same)
- Prescription Coverage:

Annual Coverage Deductible \$590 Initial Coverage: Formulary Schedule Catastrophic Coverage: Post \$2,000

Retirees are encouraged to use up any remaining Health Reimbursement Account balances in 2025. Potentially, they could lose them in the future.

Minimum problems were encountered or reported once the 2024 initial rollout was completed.

For Grandfathered Retirees

No changes to the GF Medical Plans, and there were minimal changes to the prescription drug plans as listed below

- Some Formulary co-pays were changed.
- The catastrophic out of pocket expense .prescription coverage decreased to \$2,000 in accordance with the 2025 Federal Medicare RX requirements
- Due to low participation, one plan was collapsed into another plan
- No changes to dental or vision plans. No change in any monthly premiums
- Not all AT&T Grandfathered Health Benefit plans have the same out of pocket costs such as copays etc. For this information please check with the carrier whose contact information is on the back of your ID card.

Deceased List


AT&T does not share or provide a deceased list due to privacy concerns. Those provided here are from our own records, but understand we do not always receive notifications.
